In view of the above, you are requested to please take appropriate action, as deemed fit.

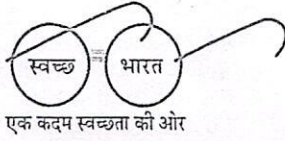


This has caused very hardship to blind students
