ABOUT THE CONFERENCE

Taking a step towards promoting women's leadership roles in academia, Association of Indian Universities (AIU) is organizing the First National Women Vice Chancellors' Conference in collaboration with Shiksha Sanskriti Uttahan Nyas and IILM University Gurugram, Haryana. The conference is hosted by IILM University in the millennium city of Gurugram from July 17 to July 18, 2023. The conference aims to bring together women vice- chancellors, educators, administrators, and members of academic bodies to discuss the theoretical and practical implications of learning, teaching, research, and administration in order to create a conducive environment for holistic development.

The event will be attended by prominent women education leaders from India and abroad, serving as vice- chancellors of various public and private universities, and handling prominent organization.

Women in leadership positions are changing the world. The rise of female leadership in communities, businesses, and political positions redefines ideas of what it means to be an effective leader. Inclusion of women Leaders in Higher Education holding various positions (such as Vice Chancellors, Deans, Directors) has ensured diversity and inclusiveness and has witnessed greater impact on the culture of the institutions. Though women participation is encouraged in Higher Education, gender parity in top leadership roles at universities are still lacking. As per the most recent Times Higher Education World University Rankings 2021, only 20 per cent of the top 200 higher education institutions the world over is led by women. The statistics on women leadership in India paints a dismal picture. While many make it to mid-ranking posts such as Deans, Heads of Departments and Controller of Examination, fewer than 7 per cent of Vice Chancellors in India are women with many of them relegated to women-only universities, where it is mandated that the post of Vice-Chancellor is to be held by a woman only.

Women leadership in Indian academia is heavily skewed with over 1000 universities but less than 70 women vice chancellors. As diversity and inclusion become well-entrenched ideas in the global workspace, it is important to consider the push and pull factors that determine the rise of women leaders. Even while clarion calls are made to promote and ensure gender equity through well-meaning policies and schemes, capacity building and mentoring of women for leadership roles assume importance.

Out of 989 Noble Prizes awarded till now, there are 61 women winners and 928 men have received the Noble Prize. We need a culture in science that encourages women to not just choose to enroll in STEM, but that also supports them to complete the graduation and join the STEM workforce. One of the key reasons that women do not persist in STEM is the combined effects of a “chilly,” “weed-out” and “masculine” culture of STEM, which favours men. STEM pathway or pipeline studies have shown that culturally responsive curricula and pedagogies, same-gender faculty mentoring, inclusive interactions with peers, and networks and women role models through professional associations are crucial factors to promote the retention of women in STEM fields.

On a global scale, Higher Education needs to close the gender gaps by promoting more women leaders, who would be instrumental in achieving all but more significantly the following three Sustainable Development Goals namely:

Goal 5: Achieve gender equality and empower all women and girls

Goal 8: Promote sustained, inclusive and sustainable economic growth

Goal 10: Reduce inequality within and among countries by 2030

Objectives of the Conference:

This conference has multi-fold objectives as listed below:

- To sensitise top-level women academic leaders towards reforms and challenges in higher education
- To enable women academic leaders to focus on globalisation of higher education
- To provide ways and means of administering tech-enabled higher education system.
- To skill the women workforce to create Atmanirbhar Bharat.

Conference Sessions Details:

Session I: Gender Equity and Inclusivity in Higher Education

Gender Equality & Inclusiveness are fundamental to the development process. Equity is the provision of fairness and justice in the distribution of benefits & responsibilities between women, men, and all genders. Inclusiveness creates belongingness amongst the people in society. Gender Equity and Inclusiveness in Higher Education would fuel sustainable economies and benefit societies and humanity at large. Sustainable Development Goals 5 and 10 of the United Nations 2030 Agenda focus on achieving gender equity and reducing inequalities through social, political & economic affairs.

One of the key aspects of promoting gender equity in higher education is ensuring equal access to educational opportunities. Efforts have been made to remove barriers that prevent women and other marginalized genders from accessing higher education. Scholarships, grants, and financial aid programs have been implemented to provide support and increase enrolment rates for underrepresented groups. Additionally, outreach programs and mentorship initiatives have been established to encourage young girls to pursue higher education and STEM fields.

However, inclusivity goes beyond access and also focuses on creating a supportive and inclusive learning environment. Higher education institutions have to adopt & implement policies and practices that address gender-based discrimination and harassment. Anti-discrimination policies and codes of conduct need to be devised to ensure they are comprehensive and protect all students, regardless of their gender identity or expression. Further, training programs for faculty and staff are re-revised to

increase awareness and sensitivity to gender-related issues and create a more inclusive classroom experience.

Also, curriculum has to be diversified to include a broader range of perspectives and experiences. Of late, gender studies and women's studies programs have gained prominence, exploring the social, cultural, and historical aspects of gender, as well as the contributions of women and marginalized genders in various fields. This can help in eliminating gender stereotypes and in promoting a more nuanced understanding of gender issues. Focussed policy initiatives are required to increase the representation of women in leadership positions, such as university administration and department chairs to ensure that diverse perspectives are incorporated into decision-making processes. Similarly, efforts to diversify the faculty are required, with a focus on recruiting and retaining women and individuals from underrepresented groups. This will help in creating a more inclusive learning environment and in fostering diverse academic discourse.

Gender equity and inclusivity in higher education are essential for creating a fair and inclusive society. Higher education institutions can foster an environment that embraces and celebrates the gender diversity by ensuring equal access, promoting an inclusive learning environment, diversifying the curriculum, increasing representation, and supporting student-led initiatives. The efforts in this regard would benefit the individuals directly involved and contribute to a more equitable and inclusive society as a whole.

Session II: Roles and contribution of women in promoting Higher Education

Women's participation in higher education helps to achieve gender equality in the society and economy. The Gross Enrolment Ratio of Women in India is reasonably good, but yet participation of marginalised and disadvantaged groups is at the minimal. Measures such as 'Gender Inclusion fund' and 'Special Education Zones' (as proposed in NEP 2020) would pave for inclusion of socially and economically disadvantaged groups. Further, internationalisation of higher education becomes imperative for learner today which would be fostered through internationally relevant curricula, brand building of Indian HEIs, academic and research collaborations with foreign universities, credit recognition under twinning agreement, global citizenship approach and engaging with foreign alumni

Women have played pivotal roles in promoting higher education and have made significant contributions to its advancement. Throughout history, women have fought tirelessly for their right to education and have been instrumental in creating opportunities for themselves and future generations. Their contributions have been multifaceted and far-reaching, spanning various domains of higher education.

One of the key roles' women have played is in establishing and advocating for women's colleges and universities. These institutions have provided a safe and supportive environment for women to pursue higher education when traditional

universities were largely inaccessible to them. Women like Savitri Bai Phule paved the way for women education and helped establish the foundation for future advancements in women's education.

In addition to their roles as advocates and founders, women have made remarkable contributions to various academic disciplines. Women scholars have achieved groundbreaking discoveries and advancements in fields ranging from mathematics and science to literature and social sciences. For example, Marie Curie, a Polish-born scientist, became the first woman to win a Nobel Prize and the only person to win Nobel Prizes in two different scientific fields. Her work in radioactivity revolutionized the field of physics and inspired countless women to pursue scientific careers. India's rich history is replete with examples of several great scientists who have brought immense pride to the nation. Among them there are several women scientists like Anandibai Gopalrao Joshi, Janaki Ammal, Kamala Sohonie, Asima Chatterjee, Rajeshwari Chatterjee, Kalpana Chawla, Dr. Indira Hinduja and Dr. Aditi Pant who have contributed significantly to various disciplines of science. Their lives are role models for all girls who aspire to make a mark in the field of science and technology.

इस हेतु सरकार, शैक्षिक संस्थान एवं सामाजिक शैक्षिक संगठन एक मंच पर आकर संयुक्त रूप से एवं अपने-अपने स्तर पर प्रयास को आगे बढ़ाए इस हेतु विभिन्न स्तरों पर ‘ज्ञानोत्सव’ का आयोजन किया जा रहा है।

Smt. Smriti Zubin Irani
Hon'ble Union Minister, Women &

Born on 23rd March 1976, Mrs. Smriti Zubin Irani was elected to the Rajya Sabha, the Upper House of Indian Parliament representing the State of Gujarat in 2011. In August 2017 she was re-elected to Rajya Sabha from the state of Gujarat. In the 2019 General Elections, she was elected to the House of the People 'Lok Sabha' from the constituency of Amethi in Uttar Pradesh by defeating the then National President of the Indian National Congress. Mrs. Irani is currently serving as the Union Minister for Women & Child Development and Minister for Minority Affairs. She has previously served as the Union Minister for Education (formerly known as Human Resource Development) from May 2014 to July 2016, Minister for Information & Broadcasting from July 2017 to May 2018 and Minister for Textiles from July 2016 to July 2021.

As Education Minister, Mrs. Irani introduced various educational reforms to upscale India's capacities in the field of research, innovation and technology. She was instrumental in conceiving the New Education Policy of India and initiated several large scale projects including India's first MOOC platform SWAYAM, the National Digital Library and a Global Network of Academicians called GIAN. She launched IM-PRINT to foster research, innovation and technology among students and academia. In the last three years as Minister for Women & Child Development, Mrs. Irani has worked towards strengthening women & child protection services in India; including making child pornography a criminal offence through POCSO Amendment Act. While serving as National President of her political party the Bharatiya Janta Party's Women's Wing, she successfully pursued Permanent Commission for Women in the Indian Army by facilitating legal aid to women officers. She is credited with launching of 'Saksham' - the first ever Vision Document released by any political party in India underlining policies, programs and implementation tools for the upliftment of the Differently-abled in India. In the 126th Assembly of the Inter Parliamentary Union (IPU), The World Economic Forum has named Mrs. Irani as the Young Global Leader from India for the year 2015. She has also served as the USAID Goodwill Ambassador to India for the WHO-ORS program before her political debut in India.

Besides being an active social & political activist, Smriti Irani has had a successful career as a Media Professional for over two decades starting from 1994. During this period, she worked across different fields of media including creating content for news & entertainment Television networks, films and theatre projects in 4 Indian languages. She has also authored a book and contributed as a column writer to 2 national dailies.

Dr. Kiran Bedi
Former Lieutenant Governor
Union Territory of Puducherry



Dr. Kiran Bedi, PPMG, PNBB (born 9 June 1949) is an Indian social activist, former-tennis player who became the first woman in India to join the officer ranks of the Indian Police Service (IPS) in 1972 and was the 24th Lieutenant Governor of Puducherry from 28 May 2016 to 16 February 2021.[2][3][4] She remained in service for 35 years before taking voluntary retirement in 2007 as Director General, Bureau of Police Research and Development.

As a teenager, Bedi was crowned the national junior tennis champion in 1966. Between 1965 and 1978, she won several titles at various national and state-level championships. After joining the IPS, Bedi served in Delhi, Goa, Chandigarh and Mizoram. She started her career as an Assistant Superintendent of Police (ASP) in the Chanakyapuri area of Delhi, and won the President's Police Medal in 1979. Next, she moved to West Delhi, where she brought about a reduction in crimes against women. Subsequently, as a traffic police officer, she oversaw traffic arrangements for the 1982 Asian Games in Delhi and the Commonwealth Heads of Government Meeting 1983 in Goa. As Deputy Commissioner of Police of North Delhi, she launched a campaign against drug abuse, which evolved into the Navjyoti Delhi Police Foundation (renamed to Navjyoti India Foundation in 2007).

In May 1993, Bedi was posted to the Delhi Prisons as Inspector General (IG). She introduced several reforms at Tihar Jail, which won her the Ramon Magsaysay Award in 1994. In 2003, Bedi became the first Indian and first woman to be appointed head of the United Nations Police and Police Advisor in the United Nations Department of Peace Operations. She resigned in 2007, to focus on social activism and writing. She runs the India Vision Foundation. During 2008–11, she hosted a court show Aap Ki Kachehri. She was one of the key leaders of the 2011 Indian anti-corruption movement, and joined the Bharatiya Janata Party (BJP) in January 2015.

She has been awarded as Best Women Parliamentarian in December 2019 - by Lokmat Media Group.

Ms. Kala Ramachandran, IPS
Commissioner of Police,
Gurugram- Haryana



Ms. Kala Ramachandran has created history and become the first woman Police Commissioner of Gurugram. Apart from being the first woman at this post, Kala Ramachandran has many feathers in her cap. She is only the second IPS Officer of ADGP rank, after Mohammad Akil, who has been given the charge of executing the duties of the Police Chief of Gurugram. Though her career remains largely dominated by her stint with the Intelligence Bureau, the journey to this place spanned across departments and was full of a variety of experiences.

Kala Ramachandran is originally from the Tamil Nadu cadre of officers. Her work with the Haryana cadre started only after she got married to the senior IPS officer Navdeep Singh Virk. While Ramachandran has also discharged her duties at the level of Joint Director, her husband Virk was also a former Police Commissioner of Gurugram. Ramachandran's career at the Haryana cadre had several stints like SP Rewari, Panchkula and Fatehabad. Her being posted at the ADGP rank happened only in Panchkula.

The appointment of the first woman Police Chief came at a strategic time when the Gurugram Police has found itself in the middle of several controversies. Be it the issue of crime in the city or alleged bribe cases of the officers, issues in the city's police have surfaced every now and then. Kala Ramachandran puts forward her ideas for the betterment of city and the police force. While her aim is to make Gurugram a safer and better city for its residents, especially women and children, she also wants to focus on traffic problems. Talking to PTI she said, "I will spell out my detailed plans when I join and meet my team but my basic goal of strengthening basic policing is very clear. As police personnel, I would ensure that the entire force works towards making the city and its residents safe and secure."

Professor Ved Kumari is former Dean and Head, Faculty of Law, University of Delhi. She began teaching law in 1983 and has taught graduate and undergraduate courses in the University of Delhi, Jammu University in India, and Vanderbilt University (USA), supervised LL.M. dissertations and Ph.D. Theses. She has written many books and innumerable articles in national and international journals. Professor Ved Kumari's areas of primary academic interest are juvenile justice, criminal law, gender discrimination, clinical education, judicial training. She is the first and perhaps the only woman academic to hold such a prestigious position. She initiated several landmark changes in the teaching and training of judges during her tenure. She introduced participatory learning with a range of innovative participatory teaching methods in judicial training and organized two Training of Teachers Workshops to training judicial officers in the art of teaching.

The Village Immersion Programme for Judicial Officers is a pioneer programme evolved and introduced by her in the One-year Training Schedule for the newly recruited judicial officers to expose them to various social issues like poverty, gender discrimination, education, etc. at the grass root. She also conceived and successfully directed the first and so far the only E-course on Judicial Ethics and Conduct for judicial officers in collaboration with the Commonwealth Judicial Education Institute, Canada. She is the Fellow of Commonwealth Judicial Education Institute, Canada (2010); Commonwealth Fellow at Warwick University, UK (1998); and Fulbright Fellow at Vanderbilt University, USA (1997). She spent one year in Russia doing research on the Law and Advocacy in Relation to Children in Russia as part of her sabbatical leave in 2005. Prof. Ved Kumari's greatest contribution is in the field of Juvenile Justice in India. She was introduced to Juvenile Delinquency in 1978 by Prof. Lotika Sarkar during her LL.M. course. Her first book Treatise on the Juvenile Justice Act 1986 published by the Indian Law Institute in 1993 is a pioneering book on the subject and has been referred to as the Bible in the field of Juvenile Justice by the social activists working with children. Her later books Child Advocacy International Perspectives (ed) (2004

She had pointed out in the book the lacunae in the classification of offences as petty, serious, and heinous and taken the position that the residuary offences not covered in these definitions should be classified as serious and not heinous. The same was held later by the High Courts of Delhi, Punjab, Patna and Bombay and confirmed by the Supreme Court of India in Shilpa Mittal decided on 9th January 2020. The JJ Amendment Bill 2021 as passed by Lok Sabha too has modified the definition to include the left over offences within the ambit of Serious Offences as suggested by her.
