**Subject: Sportspersons Tested Positive for Using Dope Substances and Sanction(s) imposed by Anti Doping Disciplinary Panel for the years from 2012-13 to 2014-15.**

Dear Sir,

Performance enhancing drugs are no longer restricted to the high stake world of professional sports. Alarmed by the present dangerous trend, National Anti Doping Agency (NADA) expressed their serious concern over the growing menace of doping among the university athletes. Hence, effective and preventive measures are of paramount importance to tackle the disaster being created by banned drugs with deadly side-effects on the health of youth – a hope and future of Indian sports.

During All India University Games: 2012-13, 2013-14 and 2014-15, National Anti Doping Agency (NADA) conducted random sampling on potential sportspersons. After due process of examination of samples and after having heard the view-point of accused athletes, Anti Doping Disciplinary Panel imposed sanctions against the guilty athletes in accordance with the existing rules of the NADA to make university sports drug free.


In view of above, you are, therefore, requested to change the results after deleting the names of those participants who were found guilty of violating NADA rules and forfeit their Certificate(s) of Merit or medals issued to them during the National/Zonal University Games organized by your esteemed University/ Institute without fail.

It may please be noted that marks claimed by the contesting universities for the performance of those sportspersons who are found/tested positive for using banned drugs, shall not be considered/ counted for the award of MAKA Trophy: 2014-15. A copy of latest list of Banned Athletes is enclosed at Flag "A" for ready reference. **The original certificate(s) distributed to the offenders, if any, shall be returned to the AIU for cancellation.**

A prompt action will be highly appreciated, in this regard.
