12. To Report the Status of Question Bank

Question Banks in 30 subjects covering various disciplines have been taken up by Research Division. Collaborations have been made with three Universities namely University of Rajasthan, Jaipur, Sant Baba Gadge Amravati University, Amravati and Panjab University, Chandigarh for preparation of Questions Banks. Two workshops each were organized at Rajasthan University, Jaipur and SBGA University, Amravati respectively. Contents in various subjects for Question Banks were developed. Item preparation is in progress.

- i. Universities of Rajasthan, Jaipur, Sant Baba Gadge Amravati University, Amravati and Panjab University, Chandigarh to whom the projects were outsourced for preparation of Questions Banks be contacted to know the status. The Universities also be asked to submit utilization certificates and report of the work done.
- *ii.* It was also decided to explore the possibility of getting funds from MHRD for the project.

- d) The states which have not initiated student research convention to be requested to start the activities in line with AIU at state level which will attract potential researchers of the future.

It was resolved that:

- I. the Guidelines, Rules, Regulations and Terms and Conditions duly approved by the Governing Council initially in 2007 be maintained and the new guidelines brought in amended form stands repealed.
- II. in future, if any teacher research activity is conducted by AIU, it should not be mixed with Student Activity in the same scheme.
- III. in addition to the awards to the position holders, some promotional awards also be given to the participants next in series to the first, second and third prize winners.
- 14. Research Division of AIU is the Academic Wing of the Association. The Salary Structure and promotional avenues the Staff of the Research Division be differentiated accordingly at par with the faculty of Central Universities Academic Grade Pay. Byelaws applicable for the Research Division be inserted as a Separate Section in the AIU Bye Laws.

It was instructed that:

Detailed Scheme with financial implication be provided with justification for Staff Affairs Committee.

The Chair proposed the idea of launching of a New Multidisciplinary Research Journal by AIU.

It was resolved to launch a multidisciplinary Research Journal of Higher. Education of National/ International standards. The Journal would contain articles from all disciplines and comparative studies of/from different countries.

Dr. S. Rama Devi Pani, In charge, Research Division was assigned the responsibility to work on the design, frame work and guidelines for the journal, and calculate the financial implications.
